- Fun Facts: 110 face-to-face, 46 hybrid, 104 virtual, 11 beginners, 1 Alateen virtual, 9 Alateen face-to-face. 25 Districts, 244 active registered groups, 260 meetings. District 16 has the most registered meetings 18. VA Al-Anon started in 1952. The Central AFG in Roanoke, VA is the longest standing meeting.

VOTING ITEMS AND DISCUSSION

Transforming Electronic Groups Policy (posted to Area website)

All questions were answered by Terry W., Task Force Committee Chair

- Gail K. asked for a recap of the motion.
- Lee S. questioned how to protect anonymity for those joining virtual meetings. We take a leap of faith. Policy doesn't address anonymity.
- Sharon the committee was to create a policy for virtual meetings to be represented in Area? The VAWSC voted to create task force to develop policy for VA Area to accept electronic meetings that petition to join or leave VA Area. Sharon if groups in district are now virtual permanently, does it change status? Yes, virtual groups must register with WSO and cease to be a part of VA area, would then have to petition to rejoin VA Area.
- Jill D once electronic group petitions to be a part of VA and a certain District would they apply to
 District along with the Area? No apply to VA Area asking to be a part of District and if approved by the
 Area, the District would decide whether they could join. Jill if district votes not to accept what
 happens? If a District says no, Area will assist with seeing if another District would accommodate
 them. Jill if District grows too large, it may become unmanageable. The same thing could happen if
 new in-person groups started.
- Elizabeth Are there changes to hybrid meetings? The last page of the Policy addresses hybrid.

SUNDAY, May 15

 - O Diane Arlington do the technical people you're looking for have to be Al-Anon members? Bruce anyone in the fellowship can help.
 - Maureen M. Will groups have to re-register because of the new policy? No, unless you want to change your group's status. Get with the Group Records Coordinator with any changes.
 - Anissa M. what is the definition of hybrid? The policy doesn't define hybrid, there are variations. Get with DR to make sure group status is accurately recorded.
 - Cheryl L. (comment) if a new electronic meeting registers will they be placed in the GEA? You will be asked Area/District you want to be connected to. Virtual and in-person meet at same time but do not conjoin, virtual meeting will need to register as separate meeting under new policy.
 - Hybrid group in-person and zoom, there is talk of separating but share officers, can they do that? If the meetings separate, the virtual will become separate group and will need to register as an electronic group.
- MEAC Wendy R. Registration for MEAC is out, July 29-31, 2022 at Camp Alta Mons. Deadline for registration is June 24 registration, \$100. Teens need permission slip notarized.
